## Relief for Venture Issuers from Certain Certification Requirements

## **BLANKET ORDER 52-501**

#### WHEREAS:

- (A) In this Order:
- (1) "Venture Issuer" means an issuer that, at the end of the period covered by annual or interim filings, as the case may be, did not have any of its securities listed or quoted on any of the Toronto Stock Exchange, a U.S. Marketplace or a marketplace outside of Canada and the United States of America other than the Alternative Investment Market of the London Stock Exchange or the PLUS markets operated by PLUS Markets Group PLC; and
- (2) "U.S. Marketplace" has the same meaning as in National Instrument 51-102 Continuous Disclosure Obligations.
- **(B)** Sections 2.1 and 3.1 (respectively) of Multilateral Instrument 52-109 Certification of Disclosure in Issuers' Annual and Interim Filings (MI 52-109) require reporting issuers other than investment funds to file:
  - (1) full annual certificates in Form 52-109F1 ("Full Annual Certificates") in respect of financial years ending after June 29, 2006; and
  - (2) full interim certificates in Form 52-109F2 ("Full Interim Certificates") in respect of interim periods ending after issuers' first financial years ending after June 29, 2006.
- **(C)** The Commission considers it to be not prejudicial to the public interest to permit Venture Issuers to file annual certificates in the forms set out in Appendix A to

this order ("Basic Annual Certificates") and interim certificates in the form set out in Appendix B to this order ("Basic Interim Certificates").

## IT IS ORDERED:

**1. THAT** pursuant to Section 20(1) of *The Securities Act*, R.S.M. 1988, c. S50, the Commission orders that Venture Issuers are exempt from the requirements of MI 52-109 to file Full Annual Certificates and Full Interim Certificates for such year and periods, respectively, provided that they file Basic Annual Certificates and Basic Interim Certificates for financial years and interim periods ending on or after December 31, 2007.
