NOTICE OF HEARING

TAKE NOTICE that The Manitoba Securities Commission ("Commission") will hold a public hearing ("Hearing") at its offices at Room 500 - 400 St. Mary Avenue, Winnipeg, Manitoba on Wednesday, the 22nd day of February, 2023 commencing at 9:30 o'clock in the forenoon or soon thereafter as the Hearing can be held, and from day to day thereafter until the Hearing is concluded, to consider:

1. whether or not it is in the public interest to order, pursuant to subsection 19(5) of The Securities Act (the "Act"), that:
 - (a) subsection 19(1) of the Act does not, with respect to such of the trades referred to in that subsection, apply to Dennis Malthouse ("Malthouse");
 - (b) subsection 19(2) of the Act does not, with respect to such of the securities referred to in that section, apply to Malthouse;
2. whether or not it is in the public interest to order, pursuant to subsection 148.1(1) of *The Securities Act* ("Act"), that Malthouse pay an administrative penalty;
3. whether or not pursuant to section 148.2 of the Act, that Malthouse be ordered to pay compensation for financial loss;
4. whether or not it is in the public interest to order that Malthouse pay the costs of the investigation and the hearing;
5. such further and other matters and the making of such further and other orders as the Commission may deem appropriate.

BY REASON OF THE FOLLOWING ALLEGATIONS:

By reason of the allegations set out in the Statement of Allegations of Staff of the Commission dated January 13, 2023.
