## Manitoba Securities Commission Staff Notice 2002-47 Categories of registration under *The Securities Act*

The Manitoba Securities Commission (MSC) is preparing a rule to detail the requirements for registration under *The Securities Act*. It is expected that the rule will be published for comment in or before February 2003.

The proposed rule will replace several policies presently in effect that define both the categories and requirements for registration. These policies can be viewed in the registration section of the commission's web site at <a href="https://www.msc.gov.mb.ca">www.msc.gov.mb.ca</a>.

In addition, the National Registration Database (NRD) is projected to go live on March 31, 2003. Commission staff have been contacting firms to update their registration information in a manner that is consistent with the information required for NRD. Although the process of updating this information has been largely completed, the continued cooperation of all registrants will help ensure a smooth transition to NRD.

Although most of the existing requirements for registration under the Act will not change with the enactment of the proposed rule and the transition to NRD, there will be changes made to the names of some of the categories of registration. These proposed name changes are intended to better describe each category of registration and do not affect the status of any registration.

The new registration category names will be shown on registration certificates starting on December 31, 2002. The existing and new category names are as follows:
